Note 1: Statement of Significant Accounting Policies

The committee have prepared the financial statements on the basis that the company is a non-reporting entity because there are no users dependent on general purpose financial statements. The financial statements are therefore special purpose financial statements that have been prepared in order to meet the needs of members.

The financial statements have been prepared in accordance with the significant accounting policies disclosed, which the committee have determined are appropriate to meet the needs of members. Such accounting policies are consistent with the previous period unless stated otherwise.

President's Report – AGM 2022

2021 was an interesting year. It seemed that the weather was determined to block all our plans. On the positive side after a season of higher rainfall than the last few years, the Park was looking fantastic by Spring.

We had organised a weekend event in support of National Science Week, with many great activities planned. Unfortunately August's rainfall had other plans. The event was postponed until October, then eventually cancelled when Park roads were once again closed due to wet weather. Fingers crossed we can organise a similar event with fewer weather issues this year!

Plans to extend our Wildflower Discovery Sessions to schools on the Eastern side of the Park were dampened by a lack of response from the schools, and the committee eventually resolved to let this go and continue to sell the remainder of the Wildflower Faces Colouring Books, which have proven very popular. On the subject of merchandise, Ron and Sue Wooller have very generously donated more Honeypossum books for Friends of the Fitz to sell. Thank you!

Thankfully the rain held off during the Ravensthorpe Wildflower Show, and Gil Craig was able to lead her walk "Understanding Plant Recovery" under the Friends' banner. Delys had taken on designing and ordering FFRNP teatowels with artwork by Julie Outram, which sold very well at the Show and throughout the year. Julie is also supporting us by looking after our Facebook page, which is very much appreciated!

In November the Committee was faced with the difficult decision of choosing a student to award our Scholarship to. We had 3 very worthy and interesting projects to consider, but after lengthy discussion decided to award the Scholarship to Tasmin Lancaster of Notre Dame for her honours research on Hakea victoria, which will be of particular interest to the Friends. We look forward to hearing more about her research as it unfolds.

We welcomed 8 new members this year, bringing us to a total of 165.

2022 is shaping up to present it's own set of challenges for events. Hopefully we will be able to organise some outdoor events to help our members maintain a connection to the Park and nature. Now that the rebuild of the Twertup Field Studies Centre is complete, it is time to revisit the Twertup MOU with DBCA, which will be an interesting project. I'd like to thank all our Committee members for your dedication and effort this year. If anyone in our membership would like to step up and join the committee, or if you're interested in organising or leading walks and events, let us know – many hands make light work!
