## Note 1: Statement of Significant Accounting Policies

The committee have prepared the financial statements on the basis that the company is a non-reporting entity because there are no users dependent on general purpose financial statements. The financial statements are therefore special purpose financial statements that have been prepared in order to meet the needs of members.

The following Australian accounting standards have been applied:

- AASB 101 Presentation of Financial Statements

- AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1031 Materiality
- AASB 1048 Interpretation and Application of Standards
- AASB 1054 Australian Additional Disclosures

The financial statements have been prepared in accordance with the significant accounting policies disclosed, which the committee have determined are appropriate to meet the needs of members. Such accounting policies are consistent with the previous period unless stated otherwise.

## AGM Twertup Field Studies Centre, Saturday 9th March, 2024 <u>President's report (includes Twertup)</u>

This year our AGM is being held at Twertup with an excursion to Calyerup Rocks on Sunday. Our guest speaker this afternoon is Malcolm French on the subject of "Eucalypts '24".

#### Activities:

#### Twertup meeting with DBCA:

16 May – A meeting to discuss fire mitigation around the building was held with Jeremy Friend and Matt Prophet (DBCA) with Al Hordacre, Nathan McQuoid and myself. It was resolved that minor pruning was required, especially at south end which Matt would get the Rangers to carry out.

An attempt was made to open the 'donation' box, but the correct keys weren't on hand. Later, Ranger Andy Benton released over \$100 which was banked in DBCA's designated Twertup trust account.

#### National Science Week:

19-20 August – Annie Leitch (wearing her Fitzgerald Biosphere Community Collective hat) organised a weekend of events for Friends members at Nowanup where Noongar Elder, Uncle Eugene Eades introduced us to the eco-restoration efforts on the property. At Monjebup North, Sarah Comer (Bush Heritage Australia) showed us their restoration efforts with direct seeding and infill planting, plus the expensive Felixer grooming traps for feral cat control. Thanks to Lotterywest who funded the weekend.

#### Twertup working bee:

9 September - A working bee at the Twertup Field Studies Centre attracted 3 participants (Kate, Libby and me) who gave the building a spring clean. The walks afterwards were exceptionally attractive as the park was in full bloom after good rains.

#### George's Gorge recce:

18 November – Troy Treeby, Nathan McQuoid and Jen Solly did an exploratory trip to George's Gorge on the Fitzgerald River for a proposed excursion by members later in 2024.

#### Merchandise and Market Days:

Annie Leitch has been managing the merchandise and has had more tea towels printed in two designs – Julie Outram's banksia and Rowena Howard's royal hakea - which are retailing at \$21 each. Jane Thomspon's popular 'Wildflower Faces' colouring book has sold out and we're in the process of getting more printed. Vivienne Hillyer's beautiful illustrated maps of the Fitzgerald Biosphere continue to sell steadily.

The main promoters of Friends' merchandise have been the Hopetoun and Bremer Bay CRCs, plus market days where Louise Lodge has kindly put our goods on her stall at Hopetoun and Leonie McMahon (Fitzgerald Biosphere Group) on a Bremer Bay stall.

#### Scholarship:

Tasmin Lancaster, Honours student at Notre Dame University, has extended her scholarship of \$5,000 to June 2024. Her research into the reproductive biology of Royal Hakea (*Hakea victoria*) and how fire affects its population dynamics is producing some interesting results. Her supervisor Dylan Korczynskyj has provided us with regular updates with some of the results already provided in *Narpulungup News*.

The relationship with Notre Dame University has been very rewarding and I have been having ongoing discussions with Dylan on how students can continue to be involved in research associated with the FRNP. It is intended that another scholarship be awarded to a post-graduate student in 2024.

## Community Stewardship Grant Application 2023:

A project titled *Fitzgerald Biosphere vegetation research and monitoring for appropriate fire regimes* was applied for through State NRM. Funding was requested to employ a senior botanist and a technical officer, however we were unsuccessful in this round. It is intended that we apply again in 2024.

#### South Coast Marine Park:

"The proposed South Coast Marine Park will provide important protections to marine species, such as the unique ruby seadragon, which is not found anywhere else in the world. The area is also home to southern right whale nurseries, vast kelp forests, vulnerable seal and sea lion colonies, precious reefs, and important fisheries. About 75 per cent of the proposed marine park will remain open for commercial and recreational fishing, with recreational beach access unchanged by this proposal (https://www.wa.gov.au/government/media-statements/Cook-Labor-Government/)"

DBCAs website provides an indicative joint management plan for the proposed Mamang Maambakoort Marine Park which extends from near Bremer Bay to Hopetoun, i.e. the offshore area from the Fitzgerald River NP. The public comment period is open until June 16. If any member would like to help the Friends formulate a submission, please contact me.

## **DBCA staff changes:**

Andy Benton (Jacup Ranger) should be here today to present a 'Ranger Report', but here's a short summary. Over the past year there have been more DBCA staff changes, with Eloise Morath (Hopetoun Ranger) and Alex Mitchell (Gairdner Ranger) leaving. It was particularly disappointing to see Alex leave as he had a keen interest in the park's flora and greatly assisted Tasmin in searching for old-growth *Hakea victoria*.

We look forward to meeting Kenneth Donohoe, the new Ranger based in Hopetoun and Greg Williams (Gairdner). Donna Higgins, a Friends' member, also joined the DBCA team in Hopetoun. We will look for opportunities for Matthew Prophet and his team to participate in Friends' activities and for us to assist the Rangers when needed.

#### Twertup:

The DBCA Trust account for maintenance of the Twertup FSC has had a total of \$3674.16 collected through accommodation fees and donations since 2018, and \$1,106.65 in expenditure. As such \$2,587.51 remains available (Jeremy Friends, pers comm, 13/2/2024).

Matt Prophet has arranged for the Rangers to maintain the water level in the batteries that store the solar power.

Thank you both for your involvement. This year's committee has worked together exceptionally well with the newer members providing added energy and taking initiative with events, merchandise and social media.

The Secretary position has been shared in 2023, as no-one was willing to take on the role. Liz and Kate have managed new memberships and the register, Annie handled the merchandise, while taking of committee meeting minutes has been shared. I have picked up the remaining duties.
